

# STATUTE OF THE ART COMPETITION FOR CHILDREN AND YOUNG PEOPLE

" Sporty family of Boguś "

## § 1

1. The organizer of the "SUPER-ECO-HEROES" competition, hereinafter referred to as the "Competition", is Intrograf-Lublin S.A., ul. Vetterów 22, 20-277 Lublin, entered into the register of entrepreneurs of the National Court Register kept by the District Court Lublin Wschód in Lublin with its registered office in Świdnik, under KRS number: 0000298405, NIP: 712-23-21-973 (hereinafter referred to as the "Organizer" ).
2. As part of the Competition, the Competition participants referred to in § 2 section 1, will produce works of art in accordance with the principles set out in these regulations (hereinafter referred to as the "Regulations").
3. The topic of the art works is: "SUPER-ECO-HEROES".
4. The competition starts on June 1st, 2025.
5. The deadline for sending art works to the Organizer is June 20th, 2025. The deadline is determined by the date of the postmark or the receipt of the competition work by the Organizer at its headquarters.
6. The founder of the prizes in the Competition is the Organizer.
7. The Organizer declares that the Competition is not a game of chance, a raffle, a mutual bet, a promotional lottery, the result of which depends on chance, or any other form of a game of chance provided for in the Act of November 19, 2009 on gambling (consolidated text: Journal of Laws Laws of 2023, item 227).
8. Participation in the Competition is free of charge.

## § 2

### Conditions for participating in the Competition and producing artistic work

1. The Competition is open to children and teenagers aged 0 to 18 (hereinafter: "Participants").
2. The competition art work must be the Participant's own work.
3. Each Participant may submit only one piece of art work to the Organizer during the Competition.
4. Art work cannot be done collectively, i.e. by more than one person (including with the help of other people).
5. Subject to section 7 the art work can be made in any technique.
6. The artistic work should be made on the template constituting Appendix 1 to the Regulations.
7. After completing the artistic work, the appropriately secured plastic trowel should be sent back to the Organizer's address or delivered in another way to the Organizer's office in a package with the note "CHILDREN'S DAY - COMPETITION"; the artistic work must be legible;
8. Participation in the Competition is tantamount to granting the Organizer free of charge the permissions referred to in section 10 and 11, for the use of the work, in accordance with the Regulations.
9. The parents or legal guardians of the Competition Participant, upon delivery of the artwork to the Organizer, allow the Organizer to make the work publicly available to all persons who wish to become acquainted with it, for the purposes of implementing and promoting the Competition, for the purposes of the Organizer's Promotion, including all activities necessary for making it publicly available. artistic work, in particular: 1) introducing artistic work to a computer, computer networks, the Internet; 2) public presentation and display of artistic work, including its placement on the Internet; 3) multiple recording and reproduction of the work using any technique, including printing, reprography, magnetic recording and digital techniques; 4) sending art work to other entities cooperating with the Organizer.
10. The authorization referred to in section 9, entitles the Organizer to grant third parties permission to use artistic work in the fields of exploitation listed in section. 9. The parents or legal guardians of the Competition Participant also allow the Organizer to display the submitted artwork free of charge during a possible post-competition exhibition and to publish the submitted artwork on the Organizer's websites and social media. Upon obtaining the permission referred to above, the Organizer also obtains, free of charge, dependent rights to the artistic work sent by the Participant, including the right to dispose of, distribute and use studies of this work, to the extent, in the fields of exploitation and under the conditions specified above, and also the right to grant permissions to dispose,

disseminate and use the works of this work in this respect and in these fields of exploitation and under these conditions.

11. Sending an artwork to the Organizer is tantamount to the Participant's parents or legal guardians expressing consent to participate in the Competition and expressing consent on behalf of the Participant to the use of the artwork in the manner specified in the Regulations.

12. Submitting an art work to the Competition involves the voluntary provision of personal data of the Participant and his/her parents or legal guardians.

13. Personal data of the Participants and their parents or legal guardians are obtained solely for the purposes of conducting the Competition and possible use of art works in accordance with the Regulations and will not be used or made available to third parties for any other purpose. The information clause for persons providing personal data for processing by the Organizer as part of the Competition is provided in Annex No. 2 to the Regulations. 14. Anonymous works will not take part in the Competition.

### § 3

#### Competition results and prizes

1. The winners of the Competition are selected by a jury appointed for this purpose by the Organizer (hereinafter referred to as the "Jury"). The composition of the Jury is determined by the Organizer.

2. The Jury will select one Winner from among the submitted works, with the reservation that the Organizer may select more than one, but a maximum of three Winners.

3. The jury will evaluate the works of art within 14 days from the deadline for sending art works.

4. The jury will evaluate the works of art in accordance with the following criteria: 1) formal criteria - compliance of the artwork with the topic of the work and the Regulations, receipt of the artwork on time, 2) performance criteria - originality, ingenuity, technique of performing the artistic work.

5. Artworks that do not meet the formal criteria will not be assessed by the Jury in terms of performance criteria and will not take part in selecting the winners.

7. Each participant of the Competition who has been qualified by the Organizer to participate in the Competition will receive one prize worth not more than PLN 100.

8. The prize for the contest winner is a set of sports merchandise signed by players from teams sponsored by the Organizer.. The prize will be awarded provided that the parents or legal guardians of the Competition Winner sign a declaration in accordance with the template attached as Annex No. 3 to these Regulations.

9. Prizes are awarded by the Jury and cannot be exchanged for other prizes or their monetary equivalent.

10. The jury has the right to award additional prizes - to competition participants who prepared interesting and worth distinguishing works of art, but were not included among the competition winners.

11. The decision of the Jury to select the winners of the Competition and award them prizes is final.

### §4

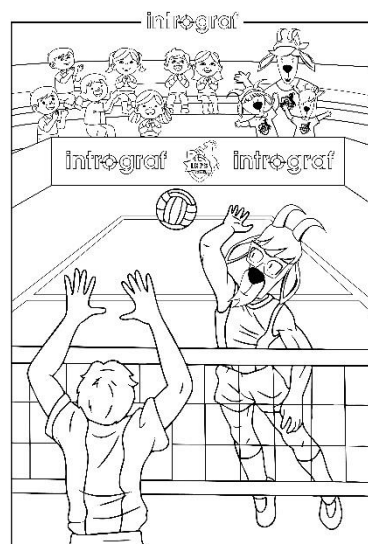
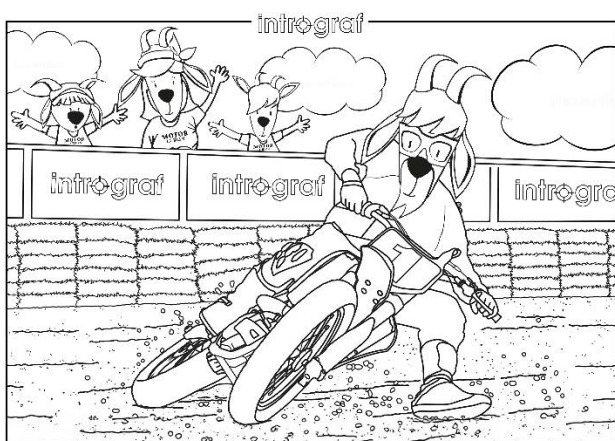
#### Final Provisions

1. The Organizer reserves the right to make changes to the Rules and Regulations, including the right to change the duration of the Contest, the deadline for submitting artwork, or the prize awarded to the Winner. The Regulations may be changed only before the deadline for submitting art works. Changing the Regulations cannot impair the rights of the Competition Participants.

3. The organizer reserves the right to: 1) withdraw from organizing the Competition without giving a reason; 2) the Competition is not resolved and the winners are not selected, in particular in the case of too few submitted works of art;
4. Disputes related to the interpretation of the Regulations or issues not regulated in the Regulations are resolved by the Organizer.

6. Submitting an art work as part of the Competition constitutes acceptance of the Regulations.
7. In matters not regulated by these Regulations, the provisions of the Civil Code shall apply.

Information clause regarding the processing of personal data

In connection with the application from 25 May 2018 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95 /46/WE (OJ EU L 119, p. 1), hereinafter referred to as the "GDPR Regulation", the Organizer informs that:

1) the administrator of personal data of the participant of the Competition for children and teenagers "SUPER-ECO-HEROES" and his/her legal guardian/parent is the Competition Organizer, i.e. Intrograf-Lublin S.A., ul. Vetterów 22, 20-277 Lublin, entered into the register of entrepreneurs of the National Court Register kept by the District Court Lublin Wschód in Lublin with its registered office in Świdnik, under KRS number: 0000298405, NIP: 712-23-21-973. 2) personal data referred to in point 1 will be processed for the purpose of conducting and adjudicating the competition for children and youth "SUPER-ECO-HEROES" on the basis of consent, which may be withdrawn at any time by sending appropriate information to the e-mail address provided in point 1 (basis for processing: Article 6(1)(A) of the GDPR). Withdrawal of consent does not affect the lawfulness of data processing carried out on the basis of consent before its withdrawal;

3) providing personal data of the Competition participant and his/her parent/guardian is voluntary, but necessary to participate in the Competition. Withdrawal of consent to the processing of personal data before the results of the Competition will make it impossible to evaluate the competition entry relating to personal data for which consent to processing has been withdrawn;

4) the use of personal data referred to in point 1, after the end of the Competition, will also be based on the legitimate interest of the administrator (Article 6(1)(F) of the GDPR) - in order to demonstrate the Organizer's rights to use the competition entry. to the extent specified in the Competition regulations;

5) personal data referred to in point 1 may be made available by the Organizer to entities authorized to obtain information on the basis of generally applicable legal provisions, and may also be published on the websites and profiles on the Organizer's social networking sites (name and surname, age, participant Competition);

6) personal data referred to in point 1 will not be transferred to a third country/international organization;

7) personal data referred to in point 1 will be stored for the period of use of the competition entry by the Organizer (in connection with the use of the competition entry, the Competition Organizer must be able to demonstrate to third parties that it has the rights to this entry);

8) the Competition participant and his/her parent/guardian have the right to access their personal data and the right to rectify, delete, limit processing, the right to transfer data, the right to withdraw consent at any time without affecting the lawfulness of the processing carried out on the basis of based on consent before its withdrawal and the right to object (in the case of data processing for the purposes referred to in point 5 above);

9) the Competition participant and his/her parent/guardian have the right to lodge a complaint with the President of the Personal Data Protection Office (PUODO) if they consider that the processing of personal data referred to in point 1 violates the provisions of the GDPR regulation;

10) personal data referred to in section 1, will not be subject to profiling.
